**Please note**: Pet food should have some sort of meat as the FIRST ingredient. The pantry managers ask that people not donate food with corn as the first ingredient as it is harder on animals' stomachs.

Don't' bring your 4-legged into the dog park if showing any symptoms

## Bordetella - it is making the rounds again!

Several members have recently mentioned Bordetella (Kennel Cough) cases being reported at other facilities around town. As of this week, SWCDP has only received notice about one member dog being affected; and he is under Veterinarian care. Speedy recovery, Nico. Please let us know if your dog shows symptoms or is diagnosed with Kennel Cough.

Please be hyper aware of any changes in your dog - coughing, sneezing, etc. – and if in doubt - let your Vet diagnose and advise. Many of you will remember the horrid outbreak we endured last year -24 cases out of about 100 members who were visiting the dog park during the triple digit heat wave. It spread very quickly.

This infectious disease can travel airborne or by sharing water bowls, etc. **SWCDP highly recommends an annual Bordetella vaccine** (some Vets recommend twice per year, especially, if you take your dog to dog intense activities, such as regular dog park visits). Unfortunately, the vaccine does not cover every strain. Just as a flu shot for humans cuts down dramatically on catching a flu bug – some bugs get by anyway. It is the same thing for the Bordetella vaccine. Due to the close playing activities experienced at our dog park, including sharing water bowls, swimming pools, and toys—the preferred course of action, is to get your dog immunized for Bordetella. It is far better to minimize the risk factor even if we cannot eliminate it all together. And if your dog has Kennel Cough – STAY HOME.

You can read an excellent article about Kennel Cough by opening the second attachment sent to you in this email. We will also post on our Yahoo Group in the Files section in the Helpful Contacts & Info folder.

**FYI:** Members attending the GMM (General Membership Meeting) in May 2013 voted to add the Bordetella vaccine as a membership requirement. This will go into effect for the 2014-2015 Season applications. For the balance of the 2013-2014 Season, we can only strongly recommend that you get your 4-Leggeds vaccinated; next Season it will be required.

# **SAFETY FIRST**



#### **Emergency Kit**

Most of the supplies for humans and canines (band aids, tapes, swabs, gauzes, cotton balls, iodine, peroxide, rubbing alcohol, StopTik, aspirin, scissors, tweezers, assorted tourniquets, scissors, wire cutters, needle nose pliers) are now located in the vertical storage locker, on the top shelf, distributed in three plastic containers.

**Use of the Emergency Kit is an honor system basis**. Please re-stock items as you use them; do not take any item off site unless absolutely necessary – and then, <u>please</u> be sure to return or replace. It is important that the Kit remains stocked so when members have an emergency or a need for quick access to resources – they can count on resources being available and easy to find. When people are stressed or in an emergency situation, they do not have time to search for things – keep everything in its place.

**Work-in-progress:** A few more supply items and expanded First Aid and Emergency tips, will be added in the upcoming weeks.

## **Emergency Contacts and Numbers**

Only use these numbers for emergency or when you cannot resolve on your own.

911	<b>Emergency Needs</b> , including health/accident/fire related. Use 911 when dealing with confrontations that might escalate or trespassers who refuse to leave dog park For faster response regarding issues not health/fire related, <i>emphasize</i> that you are having trouble and concerned that the encounter may escalate, <i>concern for safety</i> .
314/231-1212	Non-Emergency Needs, such as abandoned car, or issues that need police assistance but not of an immediate nature. Note: The 444-0100 is the South Patrol main number, but they cannot dispatch police from that line, your call would simply be forwarded to 911.
314/289-5350	Park Ranger Station for City Parks Utilize the Park Rangers for non-emergency situations, such as members violating city ordinance/park rules (e.g., coming in without a membership or bringing young children in – and refusing to leave).
636/394-1880	Wildlife Rescue Center Rehab & release injured rabbits, squirrels, game birds, reptiles.
314/426-6400	Wild Bird Rehabilitation Rehab & release injured song birds only. (636/861-3225) for raptors.



### Bags

Please bring your used grocery bags or other mid-to-small plastic bags.

Place in the large grey horizontal storage unit in the entry area. Because we have ongoing needs – it may be helpful to set a designated date to help you remember – like every Saturday, or first of the month, or each time you buy dog food, or some date or activity which will trigger your action to **bring bags on a regular basis**.

Also – help keep the bag holders on the fence filled. We use lots of bags so please get into the habit of bringing them and keeping the white bag holders filled.

A SWCDP Campaign to keep our dog park - Clean and Green

#### **Keep it Clean - Pick up the poop!**

Pick up your dog's poop – and then one more. See poop – pick it up.

Poopy paws are nasty and can make your dog sick. Dogs lick their paws and get in/out of the swimming pools contaminating the water which they – and their pals – drink. You can always wash your dog off in our Dog Wash on your way to the car so mud and poop residue are not carried into your car and home. And – do you have poop on the soles of your shoes?



The best deterrent of spreading disease – is to pick up the poop!

### **Keep it Green - Recycle!**

Blue trash cans are for recycle appropriate items only. Help us keep the park clean – and at the same time, let's recycle all plastic, paper, cans by placing such items in the blue cans. Please do not put poop in the recycle cans – it will contaminate the recycle efforts.



#### **Emptying Trash Cans Oct 1 - 18**

Our primary volunteer, Ron (Elvis, Boris), needs help.

We need 1 or 2 members to cover for Ron while he is on vacation between Oct 1-Oct 18. If you are using Alternate – and see a member in the entry way, checking out what is happening in Alternate – you MUST speak to that person to determine mutual needs and determine if your 4-Leggeds can share the space or if other arrangements can be made.

Never is it OK for such a large space to be monopolized by one dog or one membership. Everyone must share and prioritize.

#### **SWCDP Education Committee**

We need volunteers to help with this new committee

#### **Upcoming**

Each of our Four Veterinarian SWCDP Sponsors will be contributing an on-site educational session – possibly this fall. We are discussing various topics, including but not limited to: Canine CPR training, first aid and emergency tips, canine nutrition and allergies, infectious disease and general health issues, and behavioral issues and the basics of dog language and play styles. We also have a commitment from a Vet who has advanced training as a canine behavioral specialist. CGC (Canine Good Citizen) Introduction and testing (we hope, researching now). And assorted dog sports topics. If you have topics of interest – send us ideas.

#### **Proposed**

We ask that members discuss with each other while visiting the dog park – the possibility of having an on-line, very short and simple, quiz as part of the application process beginning with Season 2014-2015. The quiz would cover essential SWCDP rules and general dog language and dog play...to ensure that ALL members have the same basic knowledge before entering the dog park grounds. We feel this will help cut down on the misunderstandings and stresses caused by members not having an understanding of such information. We will likely put this to a member vote before we close the 2013-2014 Season.

We need volunteers to work on this Educational Committee. We would like to put together a series of topics over one weekend – and also run a few solo events throughout the year. Please let us know if you would like to help develop, oversee, and execute SWCDP educational efforts.

#### A Message from SWCDP Management

#### **Dear SWCDP Members**

We are very excited about the new season; we currently have 362 memberships, 32% are new members, and includes 519 dogs. **We welcome all and hope you are enjoying the summer**. Thank you for the outstanding support and enthusiasm for our dog park and for assisting with our ongoing volunteer needs. Our dog park remains one of the best around – in large part – because we have a fantastic membership and awesome volunteers.

As a dog park community, we strive for a safe and fun playground where exercise and social time is a pleasant experience for both 2 and 4 Leggeds alike. But Southwest City Dog Park is a large dog park with a lot of moving parts and variables involved in the day-to-day operations. Most days – all to the good. As your SWCDP leaders, we have agonized over when – or whether or not – to bring up the stuff on the not-so-good side. Because of recent uptick in bad behavior – by a few – we have opted to address things straight up. *So, here goes* . . .

We ask for your help to ensure that members comply with rules as required by the SWCDP membership agreement and mandated by STL City Ordinance 66595. <a href="http://www.slpl.lib.mo.us/cco/ords/data/ord6595.htm">http://www.slpl.lib.mo.us/cco/ords/data/ord6595.htm</a> Most of you joined SWCDP in good faith – having a reasonable expectation that the rules you agreed to follow would also be practiced by the other SWCDP members. The St Louis City Parks Department issued a "revocable" dog park permit to SWCDP – in good faith – with the expectation that those in charge of dog park management would oversee ordinance compliance. Expectations include vetting and permanent record keeping of membership, maintaining a \$1,000,000 commercial liability insurance policy, adding the City as a certificate holder, and having a signed waiver from members holding the City harmless of potential damages. Our permit is reviewed each year; and can be revoked at any time, upon the discretion of the Park Commissioner, if we are found in non-compliance of the ordinance.

SWCDP management is accountable to the Parks Department & our sponsor, Southampton Neighborhood Association. They rely on us to carry out the management and operations responsibilities and SWCDP management relies on our members to help us carry out such crucial and essential tasks. You may have noticed – we do not have a Lifeguard at the pool station or a greeter checking dog tags at our entrance. We don't have official playground monitors, agility supervisors, general managers, negotiators, poop police, referees, or security officers walking the dog park grounds. Why you ask? Because we ALL share responsibility for making sure things run smoothly; no paid workers at SWCDP. And as we move further into the 2013-2014 Season, you will see more requests for volunteer participation in variety of areas.

Now, most of our members follow the rules, are cordial to one another and reasonable when dealing with the inevitable challenges that pop up in any venue with a high concentration of canines and humans. We do, unfortunately, have a few members – maybe 3 - 5+% – who feel the rules do not apply to them. It is this non-compliance and selfish attitude which is the catalyst for most of the contents in this Quickie News. We have selected examples of our most pressing issues (Pages 8 & 9), those which have occurred more than once and by more than one person. We are not singling anyone out – yet – giving everyone a fair chance to change their behavior. Going forward, folks, just follow the rules and let's all get along.

We ask that all of you continue reading the Quickie News so you can understand what has been happening, why we need everyone to comply with the rules, and how you can help us maintain harmony, avoid chaos, and keep SWCDP in good standing with the St Louis City Parks as well as the St Louis community at-large.

### A Message from SWCDP Management

Please take a moment to read this communiqué

When members choose to disregard a rule – they immediately shift all the burden – and work – onto the rest of the members. This is not fair or acceptable. Each member is expected to be responsible while using the dog park. When a member blows off a rule – it is equivalent to saying "the rules are for the other people, not for me". This is no good.

Now, having said that, we also do not want a Gestapo-like environment, where members are afraid to relax for fear of being reprimanded for one thing or another. Nor do we want members to bully or speak harshly to others in their efforts to enforce the rules. ALWAYS use judgment, don't pick on people, keep your cool, be cordial and diplomatic. If you are uncomfortable or unsure how your comments may come across – ask another member or two to help you discuss the situation calmly with the member (s) in question. And, realize often times, people are uncertain about what to do – so guide them gently. They may very well appreciate the help. We have seen many instances in which people were running afoul of a rule because they were "not thinking" but once called to their attention, they got on board quickly.

In closing, to the 95+% of our members – keep up the good work. And, to the small handful of members who have occasionally run afoul – please follow the rules – and stay with SWCDP. Let's clean the slate and start anew. We want all our members to enjoy the dog park. Have you read the SWCDP User Guide?

### Best Regards to All - See ya 'round the playground!

Every member was given the SWCDP rules and asked to read and agree to abide by such rules as a condition for membership – and we have those signed statements in the SWCDP membership records. We also sent a link to SWCDP User Guide in the communiqué which issued your acceptance into SWCDP membership and your dog tag (s). We do <u>not</u> want <u>anyone</u> to resign – rather – we want <u>all members</u> to have the opportunity to learn the rules and enjoy the dog park. But, if you are unhappy with SWCDP, or feel you cannot or will not adhere to our rules – we offer an 80% refund of the membership fee during August only. **SWCDP User Guide, including the rules, may be accessed on our website - <u>www.swcitydogpark.org</u> on the Membership page.** 

A One-Time Offer: After you review the SWCDP Rules and User Guide, if you feel SWCDP rules and guidelines are such that you do not agree or are not willing to follow – or that your dog is not cut out for dog park play – we will be happy to return 80% of your 2013-2014 membership fee and immediately terminate your membership.

You will need to contact Joan at <a href="mailto:secretary.swdogpark@gmail.com">secretary.swdogpark@gmail.com</a> to make arrangements. Turn in your dog tags, sign a termination agreement, and receive your refund check. We will keep a log of closed memberships and tag numbers.

This offer is only good through August 31, 2013 and will not be offered after 8/31. We believe the majority of our members support this offer because none of us want to deal with negative issues and repeat problems while we are trying to enjoy our dogs and the dog park. We do not want a few to spoil it for the many so we encourage those folks not willing to cooperate to resign their membership and find another dog park.

### **Our Laundry List of Ongoing Troubles**

If you see yourself or your dog in these situations, please make an effort to improve your dog park habits. If you see members disregarding these rules, or any SWCDP rules, tactfully ask them to adhere to the rules.

#### Foul Language, Name Calling, Bullying, Personality Conflicts

Fortunately, this doesn't happen every day. Humans tend to get emotional very quickly when it relates to their 4-Leggeds. If you are in a situation that feels tense – walk away – go find another area to hang out in or go home. If you are attempting to address a problem, such as rules being ignored or a dog scuffle, please remain calm. Take a deep breadth, ask other members to help you. Whether you are approaching someone who is clearly disrespecting SWCDP rules, or questioning someone about their membership status (as in, no current dog tag), or simply disagreeing with a member regarding dog play and behavior – keep it civil.

Rough patches between last 2 mo and first 2 mo

Thankfully, our dog park is large enough to accommodate all kinds of human personalities and canine play styles. It is not a requirement to be totally social either. If you prefer solo visits – just find a quiet spot, or pick a different time to visit. You and your 4-Legged don't have to like every human or canine either. Use the opposite end of the park or find members you enjoy spending time with. Lots of options and ways to keep a harmonious playground.

# Beer Drinking Ongoing bad behavio

Ongoing bad behavior, likely happening after dark.

If you are the member (s) drinking on site – please stop doing so immediately. Consider this memo your first warning; no second chances – membership will be terminated if you continue to disregard the rules. Since the beginning of SWCDP operations, SWCDP rules have forbid alcohol on-site unless it is during a sanctioned – and supervised – SWCDP event. It is difficult enough for many humans to keep emotion and judgment in check while interacting with a variety personalities and supervising the fast moving dog play and unavoidable scuffles. We don't need the humans drinking alcohol while they are watching their 4-Leggeds.

Members, we need your help in stopping this behavior. If you are out and about after dark and can randomly stop by the dog park to "spot check" this problem behavior – we appreciate the help. Should you find members drinking alcohol, get their names and send report to SWCDP management via a Complaint Report. If we determine members are repeatedly abusing our rules, we will then call the Park Rangers or Police for assistance.



#### **Agility Course Abuse**

Leave gate open

#### **Leashes - Are You Lax With Your Leash?**

<u>Did you know</u> there is a \$100 fine if a Park Ranger or Police stops you for having an unleashed dog? <u>Did you know</u> that it is part of the City Ordinance and SWCDP rules to keep the dog leash with you at all times while inside the dog park? If there is a dog scuffle or injury, you need to leash your dog immediately, and there will not be time to walk up to the entry area to retrieve it. Please stop leaving your leashes in the front entry.

#### **Pool Dumping, Unattended Hoses and Mud Puddles**

When you make mud and then walk away – the next group of members will have to deal with it and somebody has to repair it. And those who are saddled with your mess are not happy campers.



#### No Current Tag No Admittance No Exceptions

Most non-tag" problems relate to legitimate SWCDP members - who have either lost their tag, forgotten the collar, etc.

BIG DEAL

We can "self-police" and manage these situations without outside help. Always question any dog inside our dog park without current SWCDP tags. If the owner can produce the tag, fine. If not, check the dog's name on our Dog Name Roster (located on the small message board in entry area). If verification is still not possible, ask the member to leave and return when they have resolved their tag problem. Such members should contact Joan for resolution. If the member is uncooperative, you can always elicit help from other members — or file Complaint Report (forms located at the large message board in entry).

Members – Please don't dump this burden on your fellow members. Keep current tags on your dogs.



#### **HUGE CONCERN** that members are passing out gate code

Because of safety and liability issues – breaking our security by sharing the gate code with family and friends is reason to have your membership terminated immediately.

People using the dog park without a legitimate membership are high risk - we do not know who they are - we have no way to get in touch with them, we have no record of vaccinations, and - we have no signed waiver (City Ordinance requirement) - holding the city harmless. We also do not have their signed agreement to follow the SWCDP rules and to be financially responsible for damages caused by their dog (s). This is a considerable problem should there be a dog fight or other serious situation requiring a follow-up or accountability for actions.

Never give the code. If you are around the entry and someone outside asks for it – you must check their dog for SWCDP tag, and then open the gate for them. Instruct them to contact Joan about the code.

We recommend each member put the code in their cell phone & hard copy in car glove compartment.



An ongoing issue, of late, we have an increase in unlawful dogs entering our dog park.

People tend to "slip in" with other members entering dog park and/or stand around entry area in hopes of figuring out the code, and recently, several have been seen entering with no tags but knowledge of our code. Escort non-members out of the dog park – show them where the membership applications are, and encourage them to join by following proper application process.

The Park Rangers are happy to enforce the City Ordinance or settle disputes. This is their job; they will decide the course of action, including writing a ticket to a trespasser or requesting people to leave the grounds, etc. We have spoken to both the Rangers and the Police who cover Willmore Park. Both have encouraged SWCDP members to call on them for situations that cannot be handled within the



Just as citations are given for fishing without a fishing license – Rangers & Police will also issue a ticket to people for

entering dog park without membership membership. We only ask that our members use this option judiciously so that Southwest City Dog Park does not become "those dog park people who call all the time".

It is only when people become antagonistic or refuses to leave that we may need outside help. Never put yourself in harms way – if a person is refusing to leave or creating a scene – call the Park Rangers or 911 immediately. This scenario works best if one of our members calls for help while another member keeps ... Try to get the license plate.

Bringing dogs into dog park without legitimate membership is violation of City Ordinance


